

GROUNDS/MAINTENANCE: PAUL SABIA SENT a letter with photographs showing the damage to the tower and the swim curtain with suggestion that repair be made while the lake is down. It was requested that Paul try and find someone who would be able to do the job. The Board expressed thanks to Faul for his timely information.

TENNIS: A TENNIS PARTY AT THE SUSSEX COUNTY RACKET CLUB IS PLANNED FOR FEBRUARY 27,1988.(SEE FLYER FOR DETAILS)
SWIM TEAM: They will hold a swim night Feb. 6,1988 at the YMCA in Randolph. Plans for the necessary platform for the swim team have been drawn. The work will be done by volunteers and the cost should be about \$3600.00 for material.Approval for this expenditure was not given at this time.

BEACH: Rules have been approved and will be handed out with the badges as in the past. The parking stickers will remain the same design. The guest parking cards will again be given with the badges.

SOCIAL: THE FEBRUARY BRUNCH WILL be held on FEBRUARY 7,1988. The cost will be; Children: \$2.00 and Adults: \$4.00, advance payment. At the door Adults will be \$5.00. Paid reservations must be made by February 4,1988.
