





LAKE FOREST YACHT CLUB - BEACH UPDATE

As of 5/18/2020 due to the Covid-19 restrictions

- 1. Lifeguards will be on duty as of 5/23 on the weekends Saturdays from 10-8 and Sundays from 10-6, weather permitting. Hours for the Memorial Day holiday will be 10-6. Seven-day lifeguard operations will begin on or around Saturday 6/27.
- 2. The Snack Shack will be open when lifeguards on duty selling pre-packaged goods.
- 3. The playground, fields, gaga pit, horseshoe pits, and basketball court remain closed until further notice.
- 4. Social events (opening day picnic, bands, etc.) will not be held until the guidance changes in this regard.
- 5. Social distancing must be practiced by maintaining at least 6 feet of distance from those outside of your household. This applies to adults and children alike. Please do not congregate in close groups anywhere on the property.
- 6. At this time, we will need to limit the number of member's guests to five (5) per day, per household. We expect all members and guests to abide by item #5 above regarding social distancing.
- 7. Restrooms will be open, however only one person, or child(ren) accompanied by a parent will be allowed to enter the restroom facility at a time. Others must wait outside.
- 8. Restrooms and other high-touch areas will be cleaned several times each day lifeguards are on duty.
- 9. Community/shared grills will not be made available until further notice.
- 10. Picnic tables are being moved to maintain social distance. Do not move the picnic ta bles.
- 11. The dive tower platform will be marked to maintain distance if a line forms.
- 12. Community/shared beach toys, noodles, kayaks, etc. will not be available until further notice.
- 13. Please remember, our lifeguards' number one priority, as always, will be concentrating on helping to ensure water safety. They will not enforce social distancing guidelines.



DEP Guidance on HABS

A new tiered approach from DEP was released May 21,202 The updated strategy takes into account data collected by DEP over the 2019 season and shows a desire from DEP to work with partners such as the Lake Hopatcong Commission, Lake Hopatcong Foundation, Princeton Hydro and other lakes groups to consider and incorporate suggestions that impact our communities. The new strategy includes six tiers, NONE, WATCH, ALERT, ADVI-SORY, WARNING and DANGER. The tiered approach is designed to notify the public of potential health effects and allow for more informed decision making by providing information on the risks associated with primary contact.

WATCH will be posted when cell counts exceed 20,000 cells to notify the public of potential less serious health effects and allow for more informed decisions. Public beaches remain open. Use caution during primary contact.

ALERT is for public bathing beach closure only and is indicated when a HAB has been confirmed, with cell counts between 40,000 and 80,000 and no known toxins above the public threshold. Beaches remain open (dependent upon local health authority) and should increase monitoring for future toxin production.

ADVISORY will be posted when cell counts exceed 80,000 cells or when toxin levels exceed 3 micrograms per milliliter of microcystins, even if cell counts are below 80,000. Public beaches closed

WARNING and DANGER tiers are designed to communicate HABs that are producing very high levels of toxins which justify additional caution. Public beaches closed.

LFYC Board Meeting Minutes

Date: May 13, 2020

Location: Conference Call – Zoom Meeting due to the Covid– 19 Meeting called to order: 7:19 pm, Meeting Adjourned: 9:34 pm Attendance: Mike Malakuskie, Vanessa Luke, Jaime Evans, Brian Richardson, Chrissy Gilligan, Vinny Gowers

<u>Mike M. – Commodore,</u> <u>Grounds/Security:</u>

-Mike is in the process of researching 2 alternative security companies for pricing and terms. A decision will be made once all of the information has been received.

-Clubhouse floors – the member who volunteered to install new floors provided a phone number of a contractor to remove the existing floor. Mike K. also provided a quote for existing floor removal. The Board will further discuss the costs and timing of this project. -Mike provided an update on the algae water treatment system. Princeton Hydro is the company that received the grant for the algae water treatments. JP Bell is an operating force/project manager subcontractor. JP Bell provided a layout with the location of the cabinet for the aeration equipment. Electrical wiring will need to be supplied and Mike is working with Norris Electric to get this done. Mike also reached out to Princeton Hydro to gather further info on the terms of use/ownership of the new equipment. -The bathrooms were de-winterized, and everything is working correctly. Mike suggested postponing the project of installing the new toilets. The Board agreed.

-The playground has a small sinkhole created by the settlement of the ground after evacuating the old septic tank. Mike will ask the landscaper to fill it. -Covid 19 – 6 feet distancing signs were ordered and delivered. The Club will display the signs on the property. Gatherings are not permitted as per the current details of the governor's order. -The playground's slide facing the Clubhouse was damaged. After reviewing the footage from the security cameras, the member that caused the damage was identified. Two Trustees discussed with the member's family and arrangements are being made with the family to handle it financially and with assistance in installing the new slide that is being ordered.

-Vinny found a sticker with the name of the company that manufactured the playground. Vanessa located the company and found that replacement parts are available. Mike M. suggested that maybe instead of replacing the whole playground we can start gradually replacing the parts that need it. Vanessa will ask the manufacturer for a few quotes. Quotes will be obtained for installation costs.

Vanessa Luke- Secretary, Office, Communications

-The semiannual meeting will not take place due to the Governor's orders. An informational prerecorded video will be supplied to membership and voting will not take place. Members need to submit any questions and suggestions ahead of the meeting

Jaime Evans - Treasurer, Financials, Legal, Insurance

-The budget for the Clubhouse does not allow room for replacing the clubhouse floor at this time. The Board suggested prioritizing the list of projects. Top priorities include water aeration, the playground, and the Clubhouse floor.

-Weedoo insurance policy was renewed.

-LFYC taxes extension was filed, taxes were pre-paid

<u>Mike K – Maintenance/</u> <u>Clubhouse/Wakeoff</u>

-Mike M. for Mike K. The Board needs to create an action items list for the maintenance employee.

<u>Brian Richardson - Docks, By-</u> Laws, Swim Team

-Dock slips are sold out. All maintenance on the B&C docks was completed. The Club needs to purchase 20 dock rings. Catwalks maintenance was completed on the day of the meeting. -Boat safety course might be rescheduled for the end of the summer. -The Swim Team is waiting for the Swim League to decide about the 2020 season.

<u>Chrissy Gilligan - Social, Schol</u>arship, Nominating

-Cassidy Espinoza was unanimously chosen as our 2020 LFYC scholarship recipient.

-The member followed up on the idea of hosting a blood drive in LFYC Clubhouse.

-The Board confirmed that the LFYC is not open to public functions and due to Covid -19 the Clubhouse is officially closed.

-Chrissy reported that no one signed up to install the catwalk weed curtain and goose control lines. Recently people have been observed pulling jet skis up to the catwalk as well as people walking on them. This situation is not safe. The Board will try to organize a few people to install curtains and goose guards. The 'Keep Off' signs are a part of the installation.

-Chrissy advised that people who are volunteering to complete cleanup/ maintenance tasks should reach out to her or Vinny for cleaning supplies or other items needed. If the Club cannot provide them, they will be reimbursed for the purchase.

Vinny Gowers- Beach/Galley/ Lifeguards

-Agra Environmental will start testing water for e coli May 18. Members can swim at their own risk. The Board will be posting updates as they come on Facebook and via emails.
