## The \$2500.00 Lake Forest Yacht Club Scholarship

*Established 2007*



This will be our 18th year awarding the Lake Forest Yacht Club Scholarship. In 2023, Elise Gilligan was the recipient of the Scholarship. We look forward to awarding another scholarship this year to a 2024 graduating LFYC member.

The scholarship will award up to \$2,500 to help an applicant's higher education endeavor. This scholarship is awarded \$1,000 after 1<sup>st</sup> semester completed, as well as \$500 after year two, three and four of college. The candidate must be a Lake Forest Yacht Club member in good standing as well as a 2024 graduating high school senior. Complete details and criteria will be found on the LFYC Scholarship Application available on March 1st on our website.

Scholarship applications should be addressed to the LFYC Scholarship Committee and e-mailed to the LFYC office no later than April 15<sup>th</sup> 2024. The five members of the 2024 LFYC Scholarship Committee will evaluate all applications and make a decision on who will be the recipient of this year's LFYC Scholarship. The recipient will be notified on or before May 1<sup>st</sup>, 2024.



## 2024 Season Dock Rental Information

Members of the Lake Forest Yacht Club have always valued the benefits we have in club membership, especially with the eighty-five dock slips we operate at our facility. Our dock slips continue to be one of the greatest assets to our club as dock rentals at any of the local marinas cost anywhere from \$2,500 and up for the season. For the 2024 season, the member rental fee for a dock slip will be \$700.00.

In early January, the club office will mail invoices and dock slip rental agreements to all members who rented dock slips in 2023 for the opportunity to renew their dock slip for the 2024 season. If you plan on renewing for the upcoming season, please return the completed and signed rental agreement along with a copy of your current boat registration and payment by March 15th, 2024.

Please be advised that the office will not accept incomplete applications or applications without copy of the current boat registration. Also, please indicate if there is any repair issue that you feel needs to be tended to regarding your slip. If you have no intention to renew your dock slip for the 2024 season, please notify the club office.

As is club policy, dock slips will only be rented to members whose: financial obligations to the club are current, have completed a signed rental agreement and provide a copy of the boat registration indicating member ownership of the boat. All of the above criteria will be required before LFYC approval of dock slip rental or renewal.

If you'd like to rent a dock slip for the upcoming season, please contact the club office at 973-663-0158. Dock Slip Rental Agreements are also available for download at our website [www.lfyc.org](http://www.lfyc.org). Actual slip assignments for new renters will be determined starting March 18th, after member dock renewals are confirmed.

## Member Guest Parking at the Club

During the off season, we often find trespassers parking at our facility to do various activities including launching fishing boats, hunting, ice fishing and other activities. To maintain security and privacy of our member only club, we are enforcing our private property policy which may include towing of unauthorized vehicles. Members should have a parking tag in their vehicle for club management to identify authorized vehicles.

For members who have non Lake Forest resident guests parking at our club, we need their vehicle to have a 1 day parking pass, as seen in the image attached, on the vehicle dashboard. Information needed so that we may confirm they are a current member's guest and not have the vehicle towed.

If you have a guest parking in our lot, please have the parking pass visible on the dashboard. The 1 day guest pass is available anytime at the club office outdoor bulletin board or can be downloaded from our website under "Forms".

This is required year round to help us manage our property and to avoid towing a member's guest vehicle.

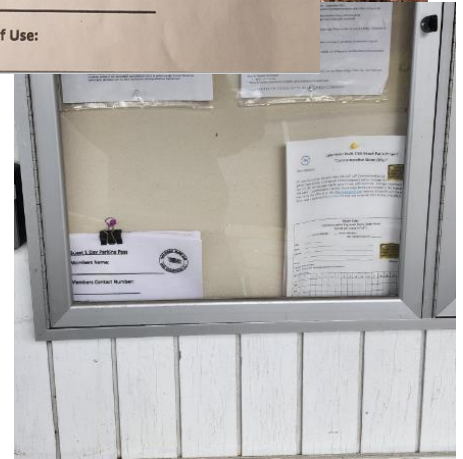


Guest 1 Day Parking Pass

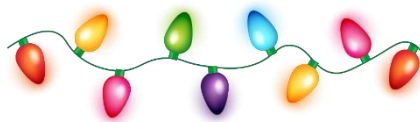

# LFYC Annual Meeting Minutes

**Meeting Date:** 12-1-23

**Attendees:** 31 members

**Called to Order:** 8:10pm

**Adjourned:** 9:48pm

Reading of previous minutes- Brian Richardson motion to waive reading of previous minutes, and Donna Fenske second, all in favor- yes

## **Treasurer Fiscal Report- Pat Brennan (Treasurer)**

- We brought in net profit of \$20,694 (Old Master Lease & Boat Races)
- Brian Richardson asked if we are on track for loan repayment status? Answer is yes and loan principal payments of \$19,425 have been completed
- Capital improvements completed within budget are Clubhouse exterior painting & repairs, natural gas conversion, dock repairs, and basketball court replacement
- Security services came in \$6,000 less than budgeted
- Sales tax is added only to our membership dues, no other items including boat slips. Other lake communities tax policies were compared to ours
- Master Lease increase coming in 2025 per our by-laws
- Dues and dock slips were raised this year to cover expenses but less than inflation rate
- Club rentals were not increased due to decrease in number of rentals
- Credit card surcharges will be increased to cover actual costs the credit card company charges us, this was not the case in the past
- Social budget increased by \$3,000
- Loan is \$300,000- We've paid off \$100,000 of loan and in 2024 we will refinance the loan. Loan payment will be about the same. Goal is to have the loan paid off in 5 years before balloon payment structure takes effect
- Chuck Emery is still our accountant/finance consultant and continues to work with Linda on our finances. Chuck has told the Board that "Books look good, and Linda is doing a great job keeping them clean"

- All accounts reconciled. By-Law procedures are being followed
- Club brings in enough money to cover day-to-day operations plus some capital improvements and we have enough money in CDs to cover bonds
- Money is properly being escrowed monthly for capital reserves
- Accounts Receivable on a downward trend over the last three years \$70K -> \$53K, meaning old past due accounts are being collected
- No past due bills to pay

## **Frank Gutowski- Commodore**

- All 85 Dock Slips Rented, sold out again this year. \$675 Member / \$2,000 Non-Member. 74 Member Renewals, 3 New Member Rentals, 3 Members 2nd Slip, 5 non-member rentals. Revenue: \$64,000. 2024 Season Plan is to raise rentals to \$700 Member / \$2,100 Non-Member and \$10K Budgeted for B & C Repairs – 5 Fingers – 2 Pilings
- Rental Fee: \$25 / \$35 per season with \$685 rental revenue allocated to repair/replace racks. Last year James Davitt did a great job fixing up the existing racks
- Repairs completed this past year: clubhouse facade, natural gas conversion, storage room cleanout, clubhouse table repairs, kegerator repairs, new TV donated by member, new LED lighting in clubhouse. April project day also had office flag pole replaced, octagon table repaired, picnic tables repaired, trash can area near B&C dock renovated, and backboard and poles of basketball courts repaired. All projects done by member volunteers
- 2024 plans for repairs: exterior painting and scraping of clubhouse and beach galley. Professionals will be brought in for this job. Clubhouse pocket doors to be cleaned up and repaired. Water spigot to be installed on far side of clubhouse and entry display case renovation
- Shade sails installed this past year to replace beach umbrellas. New Lifetime plastic picnic tables purchased as well. Materials and tables already purchased to finish the remaining island at beach to put more shade sails and NEW picnic tables

- Other projects completed: yellow slide for water installed with sand bags stabilizing it. Kids really enjoyed it. Big blue slide tower still a problem. Slide was installed incorrectly and we can't find manufacturer. We have a few members that want to try to fix this slide, otherwise we will remove it. Nighttime illumination of Dive Tower Flagpole has been installed, glare shields in parking lot installed, and water access hand rail for members installed
- New wall ball court boards installed. Cost about \$750 to fix this. To be stained in 2024
- Playground slide project- big slide has broken and board approved to replace it. Playground is 25 years old. Frank contacted original manufacturer and they had original blue prints. Total cost \$11,600 to replace slide. Funding for the repair will be from Carol Bradley's \$5000 donation for the playground and the boat races rental fee of \$6000. Installation cost is about \$4000 but may save that amount if we have members help with installation.
- Lake Forest works- small projects that need to be done and members can sign up and do at their own time. Villamarin's took on scraping, repairing, and painting the wall in the playground
- Dmitry Bohdan asked the Board do the slide parts cost \$11,000? Frank said yes. Bryan Hyland said to replace the entire playground about \$90,000
- Are there any plans to clean up the boat ramp? Yes

#### **Chrissy Gilligan- Secretary**

- Thank you to Linda for all her hard work this past year
- Porthole publication: sent via email blast and hard copies available in office
- Website: Thank you to Tony D'Alauro for his work to maintain this site
- Community Communications – Web server email blast upgrade to Outlook email blast

#### **Pat Brennan- Treasurer**

- Special project on Dredging- hole to be dug deeper on high dive area. Machine will be brought for this job. With the spoils, we will put them at the south end of the beach. We will scrap up rocks in that area and put spoils to fill area to make this part of the beach more usable. Some additional sand will be purchased for this area as well. We are also looking

at boat ramp quotes to repair ramp. While we don't have the money today to extend the ramp. Pat asked, does anyone have an issue falling off the ramp with their truck and boat because ramp is too short? Brian Richardson said he has seen people have this issue. We are looking to take rocks and fill gap area in ramp, make it level

#### **Keith Moran- Maintenance**

- Maintenance recap- Spring clean-up good turnout but End of Season clean-up not a great turn out. Because of the drawn down, the dock removal had to be booked on a separate date. Thank you to Frank and Greg Struble for their help with the dock removals
- Boating Safety Course: scheduled for March 16<sup>th</sup> 2024
- Boat Races: Sept 9<sup>th</sup> & 10<sup>th</sup> this past year, they were able to race both days and rental income was \$6000. Date being secured for 2024
- Swim Team: Kristen is now Swim Team President. Swim Team raised \$1500 at their Cornhole fundraiser
- Special Projects completed this year: basketball court resurfacing cost was \$10,800 and goose remediation with grass removal with river rock \$4500 and we saw reduction in goose issue
- Brian Richardson asked how we came to \$6000 for boat races fee? Can we add in field repairs? Boat race fix field each year as part of contract. We raised cost to this rental this past year. It won't be less than \$6000. We want rate to be fair for us but encourage race teams to continue to come back
- Dmitry Bohdan asked if camping affects the price of boat race rental? No camping permit was allowed by town so it does not affect the price

#### **Kristen Brown- Social**

- Beach operations- good summer and operations ran smoothly, we had many issues with non-members coming onto beach and club property but we were able to easily get them to leave. Scott Davis is still beach director and Michela Schultz was head lifeguard. Deep water swim test with wrist bands incorporated this past year and will continue next year
- Social Events- Lots of events this past year. During the summer, we had crafts on the beach and ice

cream socials. Thank you to Jessica Skalecky for running the craft on the beach. Thank you to Andy Egan for donating ice cream for one of our ice cream socials. Camp out on the beach was well attended this year. Thank you to Terri Costigan and Carly Nagy for planning and running Pirates and Mermaids Day. Thank you to Vinny Gowers for planning all of the bands on the beach

- Thank you to Mike Malakuskie for running the annual Cornhole tournament. Closing day Luau was a huge success. DJ Earl and Rizzo's reptiles provided entertainment. The food was catered by American BBQ company. Thank you to Dave Cobb and Mike Espinoza for cooking the pig
- The Nerds played on September 17th. It was another well attended/great event
- Trunk or Treat event on Sunday October 29<sup>th</sup> had strong turnout. Activities were both indoors and outdoors at our club. Thank you to Desirae Nigro
- Upcoming events; Breakfast for Santa even 12/2, Italian cuisine Comedy Night is booked, Superbowl Party booked, adult game night and Winterfest, LRC/Texas Holdem booked, and new member welcome event
- We do two events open to all LF community nonmembers. One is community day and one is LRC event. Volunteers needed for all events. Events will be canceled if no volunteers
- Holiday decorating contest will be done
- Beach Concessions- Snack Shack- group of Moms got together and planned menu. This service is supposed to be a convenience to community. Low priced items. Took in about \$1500. Thank you to Ashley Hendricksen, Desirae Nigro, Dana Critchlaw, Jessica Skalecky, and Marya Wilpert for their help with the concession stand this summer
- Exercise classes to be booked again this summer

#### **Peter Malenda- (Frank presented)**

- Frank reviewed Peter's responsibilities and recap as Peter was not able to join due to a death in the family
- Wakeoff- another great event and revenue of \$1400. We control Beer tent and proceeds from this event and any leftover beer is for band on beach the next day. Next band is booked 8/10/24

- Security Services- Discussion last year about poor security services so Peter found a new company with successful summer results with minimal issues at a lower cost
- New cameras being added and replaced. New camera on basketball court
- Gas Conversion- Cost came to under \$4000, much less than previous board budgeted. Great job done. Same time period spends over \$1000 on propane and natural gas about \$400 need a full year to see financial impact
- Nano-bubbler- had company remove it since it was not working. We will find a bubbler on our own to aerate the water this coming summer.
- Tennis Court- Thank you to Tom Preston for sealing the cracks again. This court will continue to need maintenance as it's too expensive to completely replace it

#### **Bryan Hyland- Insurance, Legal**

- Bryan came on to replace James Davitt who had to leave due to work commitment. Insurance pricing from Selective came in at a good price this past year. We are the only lake community Selective still writes for. We will shop around to see pricing in market. The dive board is a large liability to insure our community
- Bi-laws – couple things we wanted to change but decided to leave alone and instead made a few rules changes
- Legal- no issues this past year
